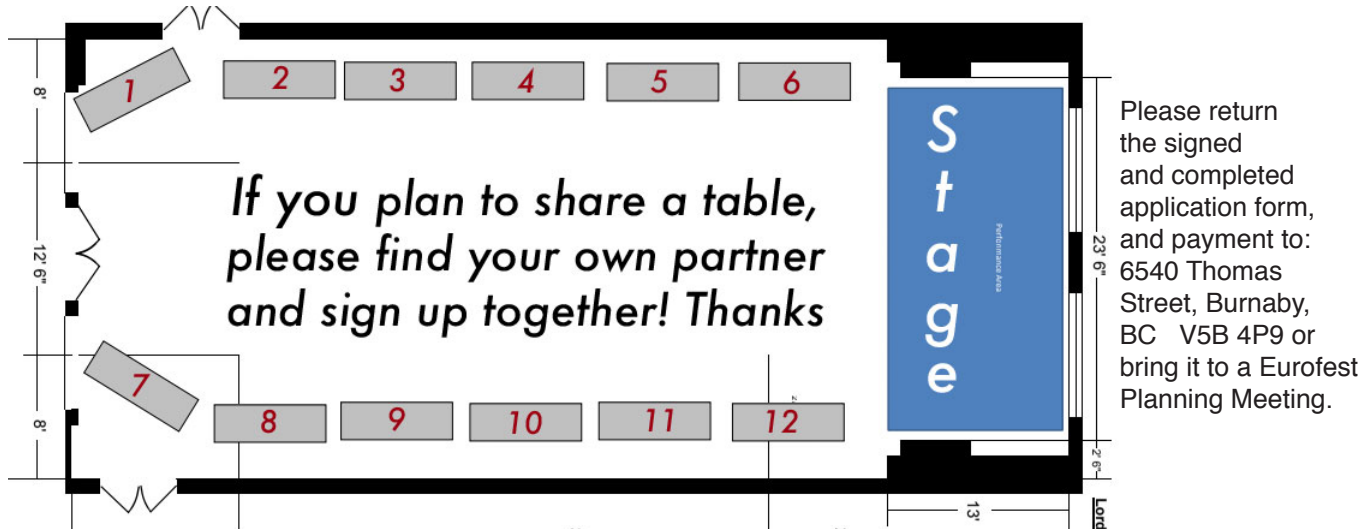

European Christmas Market - Vendor Agreement

- All food items to be sold, if any, must be listed on your application. No Styrofoam or straws permitted.
- Items to be sold are subject to the approval of the Eurofest BC Society, Vancouver Coastal Health and/or the Stanley Park Pavilion
- Cancellation Fee: 50% if done before November 1, 2019
- Vendor business or society name must be displayed at the booth
- Prices/Products must be displayed and cannot be altered during dates of event.
- Vendor must be open and staffed for the duration of the European Christmas Market. Failure to comply will result in disqualification from future markets.
- Premises must be kept clean at all times as per Vancouver Coastal Health expectations
- All vendors are responsible for removing all goods and materials from the booth after the event and leaving the space in a clean and orderly state.
- It is the responsibility of the vendor to vacate the space only after cleaning of same is completed. Failure to comply will result in further payment by the vendor of any clean up costs incurred.
- All vendors must meet and comply with regulations and will be inspected at the event by one of the following: Vancouver Coastal Health or the Eurofest BC Society
- Each table vendor is responsible for decorating and setting up their table
- Behavior and activities that obstruct or hinder the rights of others to enjoy the festival is unacceptable and prohibited, including, but not limited to: creating a disturbance, display or using profanity/obscene language directed at/or disturbing others and causing unsafe conditions.
- By completing the Vendor Application Form, and upon receiving a confirmation email from the Eurofest BC Society, all vendors participating in the Market grant permission to the Society to use any products, photographs, websites and other information in any promotional material whether in print or electronic form ("media") without any further consideration. Such media maybe used by the Eurofest BC Society in such mediums as newsletters, brochures, and in submission to local papers for publicity purposes. All vendors must sign an acceptance of Terms and Conditions below.
- I acknowledge reading, understanding, and agreeing to the terms of this Vendor Application Form. Further, the personal information collected herein will be used only for the purposes for which you have agreed to as part of this application and will be protected in accordance with the requirements stipulated in Canada's Anti-spam Legislation (CASL)
